Entrants may check official start/end times for making picks each week at http://www.playfantasygolf.com/ (the "Website"). All times in the Contest refer to Eastern Time ("ET"). Odds of winning depend upon the number of eligible entries received. Contest is subject to all applicable federal, state, provincial and local laws.

Weekly Winners (defined below) are determined solely based on the objective Golf Channel Weekly Fantasy Scoring System outlined in these Official Rules. The three (3) Teams, and corresponding Entries, that receive the highest number of Total Tournament Points for the respective Tour Tournament (or Weekly Entry Period) will be potential weekly winners ("Weekly Winners," each a "Weekly Winner"), for a total of one hundred and eight (108) Weekly Winners during the Contest Period. For each applicable Tour Tournament (or Weekly Entry Period), the Team with the highest number of Total Tournament Points will receive the first prize (each a "Weekly First Place Prize"); the team with the second highest number of Total Tournament Points will receive the second prize (each a "Weekly Second Place Prize"); and, the Team with the third highest number of Total Tournament Points will receive the third prize (each a "Weekly Third Place Prize") (collectively, "Weekly Prizes," each a "Weekly Prize").
